ਨੋਟ :- (I) ਉਪਰ ਦਰਸਾਈਆਂ ਵੱਖ ਵੱਖ ਤਰ੍ਹਾਂ ਦੀਆਂ ਅਸਾਮੀਆਂ ਲਈ Punjab Civil Services (General and Common Conditions of Service) Rules, 1994, ਦੇ ਨਿਯਮ 17 ਤਹਿਤ ਦਸਵੀਂ ਪੱਧਰ ਤੇ ਪੰਜਾਬੀ ਜਾਂ ਇਸਦੇ ਬਰਾਬਰ ਦੀ ਯੋਗਤਾ ਪਾਸ ਕੀਤੀ ਹੋਈ ਲਾਜ਼ਮੀ ਹੈ। ਇਸ ਨਿਯਮ ਦੀ ਇਬਾਰਤ ਹੇਠ ਅਨੁਸਾਰ ਹੈ:-

“17.Knowledge of Punjabi Language- No person shall be appointed to any post in any service by direct appointment unless he has passed Matriculation examination with Punjabi as one of the compulsory or elective subjects or any other equivalent examination in Punjabi language which may be specified by the Government from time to time.”

Such persons shall be given three chances to pass the examination within three years of their appointment. The modalities to conduct the practical examination from time to time shall be approved by the Government. If he fails to pass the practical examination within a period not exceeding three years from date of appointment, the Government may,

“if such person is recruited by direct appointment, dispense with his services, or revert him to a post on which he held lien prior to his appointment to the Service by direct appointment.”

- (V) The upper age limit for widows, divorcees and certain other categories of married women as per instructions issued by the Government of Punjab vide Letter No. 1/50/83-5PP(1368)/3454 Dated 23/04/1984 will be relaxed up to 40 years.
